

TOWARDS A POST 2015 DEVELOPMENT FRAMEWORK

NATIONAL CONSULTATIONS

Explanatory Note

In the year 2000, all the 189 Member States of the United Nations General Assembly adopted the Millennium Declaration. In recognition of the need to translate this commitment into action, 8 goals for 2015 which became known as the Millennium Development Goals (MDGs), were adopted. These goals are:

- a. Eradicate extreme poverty and hunger
- b. Achieve universal primary education
- c. Promote gender equality and empower women
- d. Reduce child mortality
- e. Improve maternal health
- f. Combat HIV / AIDs, malaria and other diseases
- g. Ensure environmental sustainability
- h. Develop a global partnership for development

During the September 2010 MDG Summit, UN Member States initiated steps towards advancing the development agenda beyond 2015 and are now leading a process of open, inclusive consultations on the post 2015 Development Agenda. In 2012, the UN Secretary General has established a UN System Task Force to coordinate preparations for beyond 2015 and support the work of the High Level Panel (*co-chaired by President Susilo Bambang Yudhoyono of Indonesia, President Ellen Johnson of Liberia and Prime Minister Cameron of the United Kingdom*) that the UN Secretary General has appointed to advise him on the post 2015 development agenda. The High Level Panel is expected to submit a report to the Secretary General in the first half of 2013. Mauritius has been selected as one of the 50 countries to hold the national consultation process to feed into the report of the High Level Panel.

The aim of this national consultation will be to stimulate discussions amongst national stakeholders and to garner inputs and ideas for a global shared vision of the “future we want” to inform the post-2015 development agenda.

As important national stakeholders of the development process, we kindly request you to fill in the enclosed questionnaire, which will take only around 15 minutes to answer. Your valuable inputs will help us feed in the global shared report on the potential shape the future ‘post 2015 development agenda’ may take.
