# Regulations made by the Minister under section 13 of the Quarantine Act 2020

- 1. These regulations may be cited as the COVID-19 (Closing Down of Premises and Restriction of Activities) (No. 2) (Amendment No. 2) Regulations 2021.
- 2. In these regulations —

"principal regulations" means COVID-19 (Closing Down of Premises and Restriction of Activities) (No. 2) Regulations 2021.

- 3. Regulation 4 of the principal regulations is amended
  - (a) by deleting the words "1 June 2021" wherever they appear and replacing them by the words "30 June 2021";
  - (b) by adding the following new paragraph, the full stop at the end of paragraph (c) being deleted and replaced by the words "; and" and the word "and" being deleted at the end of paragraph (b) —
    - (d) premises listed in Part D of the First Schedule shall be closed and remain closed to the public until 14 June 2021.
- **4.** The First Schedule to the principal regulations is amended
  - (a) in Part A, by deleting the following item —

Pre-primary, primary, secondary schools/Tertiary institutions/ Vocational training centres/Private schools (other premises designated as examination centres to be opened solely for the purpose of sitting for examinations)

- (b) in Part B, by adding the following new item —Deer hunting
- (c) by adding Part D set out in the First Schedule to these regulations.
- **5.** The Second Schedule to the principal regulations is amended by deleting the following item —

No assembly of more than 10 persons shall be allowed

and replacing it by the following item —

No assembly of more than 10 persons shall be allowed (other than in a workplace)

- **6.** The Fourth Schedule to the principal regulations is revoked and replaced by the Fourth Schedule set out in the Second Schedule to these regulations.
- 7. These regulations shall come into operation on 28 May 2021.
