Enlistment of Medical Practitioners on contract basis to serve the National Deployment and Vaccination Plan for Covid-19 and Human Papillomavirus (HPV) Vaccination Ministry of Health and Wellness

Applications are invited from qualified candidates **outside the service** who wish to be enlisted as Medical Practitioners on a month-to-month contract basis in the Ministry of Health and Wellness to serve the National Deployment and Vaccination Plan for Covid-19 and Human Papillomavirus (HPV) Vaccination.

II. AGE LIMIT

Candidates should be **below the age of 70 years** by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should be fully registered as medical practitioners in accordance with legislation in force in Mauritius.

NOTE

Candidates should submit a copy of their Certificate of Registration as medical practitioner in Mauritius and a copy of Annual Practising Certificate together with their Application.

IV. ALLOWANCE

Medical Practitioners will be paid a monthly allowance of Rs 41,250 plus travelling allowance in accordance with current regulations in force.

V. CONDITIONS OF EMPLOYMENT

- Candidates should be medically fit.
- Medical Practitioners will be required to work from Monday to Saturday from 08:00 hours to 17:00 hours. However, they may be required to work beyond 17:00 hours and on Sundays and Public Holidays.
- Medical Practitioners who have been retired in the interest of the public service or on medical ground will **not** be considered.
- The employment will be on a purely contract basis, subject to termination at any time.
- The employment on contract will not give the selected candidate any claim for permanent appointment in the Public Service.

VI. MODE OF APPLICATION

1. Qualified candidates should apply on the application forms which may be obtained during office hours on weekdays at the **Human Resource Section C, Ministry of Health and Wellness, 5th Floor, Emmanuel Anquetil Building, Port Louis.**

3. Candidates should submit their application together with **copies of their academic and professional qualifications, National Identity Card and proof of experience (if any).**

V. CLOSING DATE OF APPLICATION
