THE QUARANTINE ACT 2020

Regulations made by the Minister under section 13 of the Quarantine Act 2020

1. These regulations may be cited as the **Consolidated COVID-19 (Amendment No. 3) Regulations 2021**.

2. In these regulations —

"principal regulations" means the Consolidated COVID-19 Regulations 2021.

3. The Eighth Schedule to the principal regulations is revoked and replaced by the Eighth Schedule set out in the Schedule to these regulations.

4. These regulations shall come into operation on 12 November 2021.

EIGHTH SCHEDULE

[Regulation 15]

PART I — PREMISES OPEN TO PUBLIC SUBJECT TO CONDITIONS

1. Health club/sports centre, sports complex and/or wellness centre (including gym and spa, provided that —

- (a) not more than 50 persons are in attendance at a time;
- (b) only one person is allowed in an area of 4 square metres;
- (c) the maximum to be allowed thereat is affixed at the entrance; and
- (d) there is adequate ventilation
- 2. Place of worship, provided that
 - (a) not more than 10 persons are in attendance at a time;
 - (b) physical distancing of at least one metre is observed by every person thereat; and
 - (c) there is adequate ventilation
- 3. Restaurants/food courts/fast foods/snacks/table d'Hôte/pub, provided that
 - (a) distance of at least 2 metres is maintained between tables; and
 - (b) there is adequate ventilation
- 4. Casino and gaming house, provided that
 - (a) the maximum to be allowed thereat is affixed at the entrance;
 - (b) physical distancing of at least one metre is observed by every person thereat; and
 - (c) there is adequate ventilation
- 5. Cinema hall and theatre, other than concert hall, provided that
 - (a) the maximum to be allowed thereat is affixed at the entrance, the maximum number being not more than half of its maximum seating capacity;
 - (b) physical distancing of at least one metre is observed by every person thereat; and
 - (c) there is adequate ventilation
- 6. Private club (not including nightclub), provided there is adequate ventilation
- 7. Markets, subject to the control of entry and exit of persons to avoid crowding

8. Wedding *halls/salles de reception* (only for the purpose of wedding ceremonies), provided that —

- (a) not more than 50 persons are in attendance at a time;
- (b) physical distancing of at least one metre is observed by every person thereat; and
- (c) there is adequate ventilation

PART II — EVENTS AND ACTIVITIES ALLOWED TO BE CARRIED OUT SUBJECT TO CONDITIONS

- 1. Religious event/ceremony, provided that
 - (a) not more than 50 persons are in attendance at a time;
 - (b) physical distancing of at least one metre is observed by every person thereat; and
 - (c) there is adequate ventilation
- 2. Weddings/funerals, provided that
 - (a) not more than 50 persons are in attendance at a time;
 - (b) physical distancing of at least one metre is observed by every person thereat; and
 - (c) there is adequate ventilation
- **3.** Any other gathering, other than a place of work, provided that
 - (a) not more than 50 persons are in attendance at a time;
 - (b) physical distancing of at least one metre is observed by every person thereat; and
 - (c) there is adequate ventilation
- **4.** Horse racing (in camera)
- 5. Individual sports activities in open air

PART III — PLACES OPEN TO PUBLIC SUBJECT TO CONDITIONS

Public beach, only for jogging/walking/swimming activities and other sports activities (other than collective sports activities)

PART IV — PLACES/PREMISES CLOSED AND ACTIVITIES NOT TO BE CARRIED OUT

- 1. Nightclub
- 2. Bars, other than in restaurants of hotels
- 3. Children's playground

- **4.** Social hall/village hall/Municipal hall/community centre/social welfare centre/youth centre/Citizens Advice Bureau
- 5. Cultural event/social event/concerts/sports events
