Procurement of Orthopaedic Implants for all hospitals for 2 years

Please refer to your offer dated 04 February 2025 in response to our Invitation for Bids MHPQ/MDIS/2023-2024/Q20 dated 07 November 2024 on the above subject.

2. We wish to inform you that your offer for the Procurement of Orthopaedic Implants for all hospitals for 2 years as per Annex A, for the total amount of Rs 17,502,150.00 (Rupees seventeen million five hundred two thousand one hundred and fifty only) inclusive of all applicable charges, duties and taxes and exclusive of VAT, subject to the specifications, terms and conditions of the bidding documents, has been approved.
3. The packing, marking and documentation within and outside the packages shall be as follows: -
 - (i) Lot number/Catalogue number/Serial number
 - (ii) Make/Manufacturer
 - (iii) Country of Origin
 - (iv) Manufacturing and expiry date
4. The items should be delivered to the Officer-In-Charge, Surgical Stores of the five Regional Hospitals namely:
 - (i) Dr A. G. Jeetoo Hospital;
 - (ii) SSRN Hospital;
 - (iii) J. Nehru Hospital;
 - (iv) Victoria Hospital; and
 - (v) SAJ Flacq Hospital.
5. The delivery should be effected on an "as, when and where required basis" and implants and instrumentation sets should be supplied:
 - (i) within 48 hours for planned surgery;
 - (ii) within 6 to 8 hours for Emergencies and Trauma;

- (iii) supplier should make provision of a fully trained product Specialist/Technical Assistant for all cases;
- (iv) implants supplied should be of a full range, the exact size to be decided intra-operatively and only items used will be considered procured;
- (v) on each implant, the lot number, the catalogue number, the serial number, the make, the manufacturer, the country of origin, the manufacturing date and the expiry date should be clearly printed/embossed on the primary packaging material;
- (vi) each implant should be supplied in individual sterilised boxes;

9. Liquidated damages, if any, will be charged at the rate of 0.5% per day of delay by the Ministry up to a maximum of 10% of the contract price, after which the contract may be considered as terminated.

10. Upon confirmation by User Department that the items have been delivered in good condition, and in compliance to specifications, Goods Form 1 will be drawn by the Procurement and Supply Section of the respective hospital and payment will be credited to your bank account by the Finance Section of the concerned hospital after signature of Goods Form 1.

11. Any increase/decrease resulting from a fluctuation in the rate of exchange within the schedule of delivery agreed upon by the Ministry will be adjusted accordingly.






